



Payment Instructions

We accept cash, checks, wire transfers, and major credit cards.

There is a 2 percent buyer's premium discount for payment made in full via cash, check, money order or wire transfer within ten (10) days of the invoice date. Mixed payment methods are not eligible for the buyer's premium discount.

We reserve the right to hold goods until payment has cleared.

Payment via check and money order:

Please make checks payable in U.S. funds to Eldred's, P.O. Box 796, East Dennis, MA 02641-0796.

Payment via credit card:

Credit cards can only be used for up to \$5,000 of the invoice total and the card must have a U.S. billing address.

Payment via wire transfer:

All wire transmission forms differ. To ensure funds are deposited properly, please attempt to enter the following information exactly as it appears. If your transmission form cannot accommodate all required information, please use any available reference or notes fields.

Important note: In a Reference field, please be sure to include the auction date and lot number(s) or your invoice number. This is very important as it is often unclear from whom the funds were sent.

Collection of sales tax:

All purchases are subject to state and local sales tax unless:

- a) You possess a Massachusetts sales tax exemption or resale number and register that number with us.
- b) You are an out-of-state vendor who meets all the requirements of Massachusetts Department of Revenue GLC 64H 1(5) and Directive 89-10 and register that information with us.
- c) You have your purchases shipped outside the states of Massachusetts, Connecticut, New York and North Carolina directly from Eldred's by a bona fide shipping agent. **Important note:** Items shipped to states not listed here may be subject to state and local sales tax, depending on Eldred's compliance with each state's nexus requirements, as per the 2018 Supreme Court ruling South *Dakota v Wayfair*.

Unless you meet one of the above criteria, your purchases shipped to or picked up in Massachusetts are subject to 6.25% sales tax, items shipped to or picked up in Connecticut are subject to 6.35% sales tax, and items shipped to New York and North Carolina are subject to state and local sales tax.
